- Casey compared De Anza's student registration system to MiraCosta College's student registration system. She also presented her asks for the college which were to adopt a unit total based system, making the registration process more transparent for students, and to explain why the algorithm assigns students to certain times.
 - Discussion occurred regarding next steps for bringing this to the college.
