SLO Process To Do's for 2013-14



FALL 2013

⇒ Divide up SLO statements that need to be assessed among faculty in your department. **Goal is to complete 100% of the course level Student Learning Outcome Assessments & 100% of the assessments for the Program Level Outcomes by the end of Winter 2014 at the latest so that the data may be used in completing the Comprehensive Program Review.** SLO/PLO assessment data will be considered as evidence for resources.

⇒ Run Reports Showing SLOAC Progress and PLOAC progress:

Reports Tab -> Ad Hoc

⇒ Declare SLO statements appropriately as Active, Course Not Currently Taught, Course to be Deleted, Inactive, Special projects, etc.

Course Assessment Planning Tab -> Student learning Outcomes Sub-tab and click on “edit”

⇒ Meet in January for a TracDat Party to enter assessment data into TracDat. Feel Free to invite Tono or Mary. Make use of the SLOAC Worksheet (<http://www.deanza.edu/slo/tracdat.html>) to collect information.

WINTER 2014

- ⇒ Continue Catch-up on any SLO/PLO assessments that are incomplete
- ⇒ Early Winter - Liaisons will meet for instructions on completing Comprehensive Program Review
- ⇒ Workshops held for Department Chairs on completing Comprehensive Program Review
- ⇒ Presentation to Deans demonstrating their role in the Comprehensive Program Review
- ⇒ One agenda item for **each** department meeting during Winter quarter should be focused on a portion of the Comprehensive Program Review
